7 - Deposit

A deposit of 25% of total Holiday cost or full amount when travel is within four weeks has to be paid. *Holiday reservations will be considered cancelled if booking form is not received duly filled together with deposit within four weeks or full amount when travel is within four week of reservation date.*

TERMS AND CONDITIONS OF YOUR BOOKING:

Your accommodation will be available from 1400 Hrs on day of arrival and premises are to be vacated at 1200 Hrs on day of departure. Late check out may be available depending on whether or not there is a successive holiday booking. The information provided by yourselves in the booking form refers to the number of nights accommodation reserved for you. If your flight arrives at night your accommodation will be ready for you and that night will count as one of your holiday nights. It is standard international practice to vacate premises at noon even though your flight may leave later on in the day.

Cancellations:
